## **TERMS & CONDITIONS**

We hereby apply for credit with Ace Hardware and agree to the following regarding all purchases using the Ace Hardware Business charge.

- We will have the privilege of a 30 day business charge account, in which we will pay the full amount of all merchandise purchased within 30 days from the date of each billing statement.
- All accounts have a credit limit of \$ 600.00 or 20 % of the total amount paid on the account during the last twelve months, whichever is higher. Any other credit limit must be arranged with the Ace Hardware Credit Manager.
- 3. If we do not pay the full amount for all merchandise purchased within 30 days from the date of each billing statement, we agree to the following: We will incur and pay a finance charge which will be computed at a periodic rate of 1.5 % per month (an annual percentage rate of 18 %) on that portion of the previous balance remaining after deducting payments and credits prior to the current closing date. The minimum monthly finance charge is \$
- 4. If we do not pay on our account as agreed or exceed the credit limit, our business charge account will be temporarily suspended unless other arrangement are made with the Ace Hardware Credit Manager.
- 5. Ace Hardware will send us a statement each month which will show the unpaid balance for merchandise purchased including the monthly finance charge.
- 6. Ace Hardware may declare the unpaid balance to be due and payable if we default in making any required payment in full when due and we agree to pay Ace Hardware (or its agent) all reasonable collection expenses, attorney's fees and court costs incurred in collecting this account.
- 7. We will immediately notify Ace Hardware upon any change in our address.
